TERMS AND CONDITIONS

I hereby certify that I have this date received the above equipment and acknowledge that I personally inspected it and that it was delivered to me in good working condition. I agree to provide my own safe and secure transportation of all equipment for pickup and return. I agree that I am solely responsible for any damage to or loss of said equipment and agree to return the equipment in the same condition in which I received it. I understand that I will be charged for repair and/or replacement costs for damage caused to the equipment under this contract.

Regarding pop-up tents: I understand the tents are not designed to withstand windy weather, even if weighed down. I agree to take the tent(s) down should the wind pick up.

Regarding propane grills: I agree to use the grill with propane as intended and will not light the grill using charcoal, wood, or any other burning substance. I agree to refill all propane tanks and thoroughly clean grill(s) prior to returning to the Cordova Chamber of Commerce.

Regarding trash cans, recycling cans, and reusable dinnerware: I agree to thoroughly wash, rinse, and sanitize before returning.

Regarding sound system: I agree to use the sound system as intended with appropriate plugs, cords, voltage, etc. I agree to keep equipment protected at all times from rain and extreme UV exposure.

If I miss the return appointment date, I agree to be charged daily for each additional day the equipment is not returned, unless the original appointment date was cancelled by the Cordova Chamber of Commerce.

I am familiar with the use and operation of said equipment and I agree to use the equipment solely for the purpose for which it is designed. I acknowledge that I am assuming all risk caused by my use of said equipment and the Cordova Chamber of Commerce has no responsibility to supervise my conduct while setting up, using, or breaking down the equipment.

It is expressly understood and agreed that the Cordova Chamber of Commerce shall not be liable for any damages whatsoever arising from injuries to persons and/damage to property arising from the use, transporting or operation of, or in any way connected with said equipment or any part thereof.
